Fact sheet Dust Diseases Care

Dust Diseases Care provides a number of benefits to workers and their families who have been impacted by a work-related dust disease. This fact sheet provides a summary of these supports and information about who to contact if you need more information.

Workers compensation benefits

The compensation benefit is designed to compensate for the loss of income resulting from your dust disease. The benefits are payable beyond retirement age.

How are weekly benefits calculated?

The full weekly benefit is payable if you have been:

- assessed by the Dust Disease Authority's Medical Authority Panel as having a 100% disability as a result of a compensable dust disease; and
- your exposure to the dust that caused the disease occurred wholly while you were employed as a worker in New South Wales.

Duration of payments

The compensation benefit is payable for the remainder of the worker's life.

Following the death of the worker, an allowance payment will continue to be paid to the worker's spouse or partner and dependants until they are no longer financially dependent on the worker.

Medical expenses for treatment and care

Dust Diseases Care will meet the costs of reasonable medical, hospital, ambulance and related expenses for the treatment of your work-related dust disease.

Health care services and support can include:

- medical treatment and related expenses such as hospital admissions and pharmacy costs, in-home oxygen
- travel expenses to help you get to your medical appointments
- support to help you manage at home, such as support to manage your personal care, in-home domestic assistance and lawn mowing/garden care
- equipment you need to help you remain at home such as shower chairs, hire of hospital beds, and mobility aids
- modifications to your home such as installing grab rails in the bathroom or a temporary ramp for a wheelchair).

Funeral benefits

Dust Diseases Care is able to pay or reimburse up to \$15,000 for funeral costs when an injured worker who was receiving a dust diseases benefit passes away.

Compensation benefits for dependants

Dust Diseases Care compensates the spouse or partner of workers who were receiving, or were entitled to receive, compensation from Dust Diseases Care.

How are the benefits for dependants calculated?

The compensation entitlement includes both a lump sum amount and a fortnightly payment. The amount varies according to when the worker passes away. Staff at Dust Diseases Care can explain this to you.

Duration of payments

Once the transition to dependency has been completed, the dependant spouse or partner of the deceased worker will receive Dependant Fortnightly compensation payments. These payments continue for the remainder of their life or until they remarry or enter into a de facto relationship with another person.

Dust Diseases Care also pays an allowance for any dependent children until the child reaches the age of 16, or 21 if still they are still in full-time education.

Lump sum payments

Part of your compensation award includes a lump sum amount. The lump payment is separate add-on to your fortnightly benefits.
